DECLARATION OF KEITH S. DUBANEVICH IN SUPPORT OF PLAINTIFFS' MOTION FOR AN AWARD OF ATTORNEY'S FEES, REIMBURSEMENT OF EXPENSES, AND PAYMENT OF INCENTIVE AWARDS TO CLASS REPRESENTATIVES

I, Keith S. Dubanevich, declare as follows:


