

4. Attached hereto as Exhibit 2 is a summary lodestar report (including timekeeper, position, rates, and hours) for this matter. The lodestar calculation is a detailed summary indicating the amount of time spent by each attorney and professional support staff at my firm who was involved in the litigation and the lodestar calculation based on my firm's current hourly billing rates. The schedule was prepared from contemporaneous time records regularly prepared and maintained by my firm, which are available at the request of the Court. The total number of hours expended by my firm from inception through this date is 132.55 hours. The total lodestar for my firm is \$99,412.50.
